

Note: Music playback is paused during call functions and resumes when the calls ended.



How to use:

A. Charge:

- Connect the Type-C charging cable to the headphone and a USB source;
- 2. LED lights red when charging and turns off when fully charged.

B. Pairing:

- 1. With the headphones turn on, enter pairing model, LED rapidly flashes blue and red.
- 2. On your device, turn on the Bluetooth function, and set it to search for Bluetooth devices.
- 3. Select (RS3304445,RS3304446,RS3304447,RS3304448) from the list of found devices.
- 4. When paired, the LED lights up blue.

Note:

• During pairing, if the headphones are not connected to a device within 5 minutes, they automatically turn off.

D. AUX IN:

When battery exhausted or power off, can insert the 3.5mm audio cable and use it as a wired headphone.
